 - FM&C establishes requirements
 - DFAS provides technical support
 - CIO/G6 provides AKO and technical assistance
 - Near real-time financial data
 - Use AKO as the single portal
 - Enhance support to decision makers
 - Supports PSAC and KPMM for financial execution





DJAS

- Defense Joint Accounting System
 - Owned by DFAS
 - General Fund Accounting
 - Deployed at Fort Benning
 - Use as Interim System to FMMP System of the Future
 - Results of independent Price Waterhouse Coopers assessment shows substantial compliance with applicable federal financial systems requirements
 - \$8.7M needed to be fully compliant

SSF Milestone 3

- Capitalizes OMA SARSS-1 boxes into AWCF
 - 30 Sep 2002: VIOC at Fort Hood successfully completed
 - 01 Nov 2002: Conversions/implementation Army-wide
 - 03 May 2003: Completion of fielding Army-wide
- Issues impacting financial operations:
 - Computer run time
 - Logistics/Financial Reconciliations
 - Financial treatment of SARSS status codes
 - Year-end procedures and timing of catalog update

ARNG Conversion to STANFINS

- Convert ARNG from SABERS to STANFINS
- FY 03:
 - 5 USPFOs (AL, IN, NC, OK, PA)
 - Supported by 4 DFAS field sites (DNO, LW, OR, RO)
- FY 04: remaining 49 USPFOs
- Current year only
- Researching converting prior year





FINANCIAL SYSTEMS UPDATE



Leveraging Legacy Systems - AVPRAT

- Accounting Vendor Pay & Analysis Tool
 - Run at DFAS Field Sites
 - Reconciles Vendor Pay Contract File with ULO File
 - Mitigates problems at time payment is made
 - Reduces Prompt Pay Interest, UMDs and NULOs





FINANCIAL SYSTEMS UPDATE



Leveraging Legacy Systems – Obligation Matching

- ODS matches entitlement data (CAPS, IATS) with ULO data (STANFINS, SOMARDS, etc)
- Obligation < \$2500 and no match
 - Create obligation
 - Notify customer
- Obligation >\$2500 and no match
 - Notify fund holder
 - Wait 10 days
- Prototype test
- Review prototype results and field Army-wide



Wide-Area Workflow (WAWF)

- Wide Area Workflow
 - Owned by DISA
 - Automates Invoicing & Receipt/ Acceptance
 - DOD-approved solution
 - ASA(ALT) and ASA(FM&C) jointly sponsoring pilots at selected sites.
