# **APPROPRIATION LANGUAGE**

For construction, procurement, production, and modification of weapons and tracked combat vehicles, equipment, including ordnance, spare parts, and accessories therefore; specialized equipment and training devices; expansion of public and private plants, including the land necessary therefore, for the foregoing purposes, and such lands and interests therein, may be acquired, and construction prosecuted thereon prior to approval of title; and procurement and installation of equipment, appliances, and machine tools in public and private plants; reserve plant and government and contractor-owned equipment layaway; and other expenses necessary for the foregoing purposes, \$3,169,239.00 to remain available for obligation until September 30, 2019.

Amendment Justification: This increase requests an additional \$8.333 million from the PB 2017 Request. Supports both the update of the Stryker Technical Data Package (TDP) to incorporate platform Command, Control, Communications, Computers, Intelligence, Surveillance and Reconnaissance (C4ISR) modifications and the completion of Blue Force Tracker 2 (BFT2) retrofit onto the Stryker fleet. Supports the Active Army.

The purpose of this program is to upgrade M1/M1A1 tanks to the M1A2 System Enhancement Package (SEP) configuration in order to enhance tank survivability, the automotive power pack, computer systems, and night vision capabilities. The system support funds are essential to fill shortages of US Army 60mm and 120mm mortar systems resulting from Army Reorganization of Infantry Brigade Combat Teams from 3 Battalions per Brigade to 4 Battalions per Brigade.

FY 2017 OCO procurement dollars in the amount of \$22.410 million supports the replacement of 160 M224A1 (60mm), 75 M252A1 (81mm), and 44 M120 (120mm) combat losses and washouts from combat operations from Threater Provided Equipment (TPE) accounts.

Amendment Justification: This increase requests an additional \$8.200 million to procure 36 M120 (120mm) mortar systems from the PB 2017 Request.

### **Description:**

The LW155 (M777A2 howitzer) provides direct, reinforcing, and general artillery fire support to maneuver forces. The Army has fielded the M777A2 to their Stryker Brigade Combat Teams, Fires Brigades and the National Guard. The Army began fielding Infantry Brigade Combat Teams starting in FY14 and will continue through FY18. The Marine Corps has fielded to all active and reserve units. The M777A2 is capable of firing the 155MM Excalibur Precision-Guided munition, and the Precision Guidance Kit (PGK). It is a joint program between the Marine Corps and Army with additional Foreign Military Sales purchases from Canada and Australia. It is an excellent example of a successful joint service program with the Marine Corps. The M777A2 is seeing significant action in Afghanistan and has received very high marks for its performance. With the conclusion of the M777A2 US production in November 2013, the program has entered into the Sustainment Phase of its life cycle. Having now been in the field for almost 10 years, the howitzer is going through replacement of electronic components in its digital fire control system to maintain interoperability and fulfill Joint Operational Requirements Document (JORD) requirements that were deferred during development.

### Justification:

FY 2017 Base procurement dollars in the amount of \$6.045 million supports the retrofit and composite fielding activites of previously purchased Recoil System Capability Package, Digital Fire Control System (DFCS), durability modification (Spades) for the howitzers and Training Devices. The previously purchased Recoil System Capability enhances the durability of the howitzer and addresses deficiencies in the legacy recoil system. The DFCS enhances system survivability and lethality through the ability to make tactical moves and acquire targets at a significantly higher rate than an optical fire control equipped weapon. The durability modification (Spades) increases the durability of the howitzer while decreasing weight. The Training Devices modification provides for Training Aids, Devices, Simulators and Simulations (TADSS) products for use in training artillerymen and maintainers in the field and at school houses. These products will greatly increase proficiency, safety and mission fire accuracy and are supported by the Army user community.
