3. DMPO PERSONNEL REVIEWING DD FORM 1351-2 VOUCHERS FOR MILITARY PCS TRAVEL WILL VERIFY MEMBER LEAVE DATES ARE RECORDED IN BLOCK 15 OF DD FORM 1351-2 AS DIRECTED IN REFERENCES C, D, E AND F.
4. DMPO PERSONNEL REVIEWING DD FORM 1351-2 VOUCHERS FOR MILITARY PCS TRAVEL WILL VERIFY MEMBER MISSION COMPLETE (MC) DATE IN BLOCK 15 OF DD FORM 1351-2 MATCHES THE RETURN DATE AT THE NEW DUTY STATION RECORDED IN BLOCK 16 OF DA FORM 31.
5. PARAGRAPH 3 OF REFERENCE E IS RESCINDED. DMPO PERSONNEL WILL NO LONGER RECORD ET/ATT/LV INFORMATION IN BLOCK 10 OF THE 1351-2. VERIFYING DEPARTURE, LEAVE AND ARRIVAL IN BLOCK 15 OF THE 1351-2 WILL ASSIST CONSISTENT COMPUTATION OF AUTHORIZED AND ELAPSED TRAVEL TIME BY TRAVEL PAY AND MILITARY PAY PERSONNEL.
6. ALL OTHER PARAGRAPHS OF REFERENCE E AND REFERENCE F REMAIN IN EFFECT.
