- 1. IATS VERSION 8.0 WILL INCLUDE MANDATORY TECHNICAL CHANGES. THESE CHANGES CONSIST OF COMMON ACCESS CARD (CAC) / PERSONAL IDENTITY VERIFICATION (PIV) AUTHENTICATION FOR LOGIN PURPOSES AND A MIGRATION FROM THE SYBASE DATABASE MANAGEMENT SOFTWARE THAT IS CURRENTLY IN USE TO MICROSOFT SQL (MS SQL) SERVER.
- 2. THE DEFENSE FINANCE AND ACCOUNTING SERVICE (DFAS) TRAVEL OFFICES ARE SCHEDULED TO RECEIVE IATS VERSION 8.0 IN JUNE 2021. ALL OTHER CUSTOMERS ARE REQUIRED TO UPGRADE TO VERSION 8.0 SOMETIME AFTER JUNE 2021.
- 3. IATS VERSIONS THAT UTILIZE SYBASE SOFTWARE WILL NO LONGER BE SUPPORTED.
- 4. CURRENTLY, DFAS PAYS FOR CUSTOMERS' SYBASE LICENSES. HOWEVER, THE CURRENT DFAS LICENSE AGREEMENT WITH MICROSOFT DOES NOT APPLY TO NON-DFAS HOSTED SERVERS.
- 5. CUSTOMERS WILL BE RESPONSIBLE FOR OBTAINING MICROSOFT SQL SERVER LICENSES (MOST SITES HAVE A CURRENT MICROSOFT CONTRACT). THE SQL SERVER EDITION REQUIRED WILL DEPEND ON THE SIZE OF THE IATS DATABASE. BOTH OF THE FOLLOWING OPTIONS INVOLVE A COST:
- A. FOR DATABASES 8 GIGABYTES OR GREATER, 2019 SQL SERVER ENTERPRISE IS REQUIRED.
- B. FOR DATABASES LESS THAN 8 GIGABYTES, 2019 SQL SERVER STANDARD CAN BE USED. SQL SERVER EXPRESS WILL NOT WORK AND IS NOT AN OPTION.

- 9. IN ADDITION, ALL IATS USERS MUST BE ON THE WINDOWS 10 OPERATING SYSTEM FOR MS SQL AND IATS VERSION 8.0 TO OPERATE. WINDOWS 10 IS ALSO REQUIRED FOR IATS TO USE THE MOST UP-TO-DATE DEFENSE TABLE OF OFFICIAL DISTANCES (DTOD) SOFTWARE.
