SUBJECT: Headquarters, Department of Army Fiscal Year 2021 Rate Board

2. The Headquarters, Department of Army (HQDA) Rate Board has approved FY21 indirect rates for:
 - a. U.S. Army Aviation and Missile Command
 - b. U.S. Army Combat Capabilities Development Command
 - c. U.S. Army Communications Electronics Command
 - d. U.S. Army Contracting Command
 - e. U.S. Army Geospatial Center
 - f. U.S. Army Tank-Automotive and Armaments Command
 - g. U.S. Army Test and Evaluation Command
3. The HQDA Rate Board confirms that FY 21 approved rates have been built in accordance with DOD 7000.14-R, Department of Defense Financial Management Regulation, Volumes 1-15, and all other applicable financial regulations and appropriate policies. The HQDA Rate Board will track implementation results to measure FY21 plan versus FY21 execution to ensure rate compliance.
4. Army organizations entering into reimbursable agreements with commands listed in Paragraph 2 will utilize board-approved indirect rates only. No other indirect rates may be applied.
5. Army commands interested in working with the HQDA Rate Board for the review and approval of their planned FY22 indirect rates should contact the points of contact listed below no later than 2 November 2020.


