## **Meeting Summary:**

The CMSG Chair welcomed all members and thanked them for their participation. After opening remarks, agenda topics were reviewed and discussed, starting with action updates from the 1<sup>st</sup> QTR FY15 meeting. CMSG Charter updates were incorporated, pending final signature from the USA. Members reviewed the Army Standard Labor Time Tracking (ASLTT) working group update and way ahead regarding organizational specific requirements and business case analysis for a standard labor tracking capability across the Army. Other action updates included: reviewed the draft Army Cost Management Strategic Implementation Plan; reviewed the Command Cost Model Documents schedule in the Cost & Performance Portal (<a href="https://cpp.army.mil">https://cpp.army.mil</a>); and discussed the Army Cost Managed Organization (CMO) concept for assessing Cost Management maturity levels by organization. DASA-CE communicated Cost Management Certificate Course (CMCC) training opportunities. In addition, FORSCOM and USARC provided an overview of their Cost Management programs and successes as an integral part of leadership's resource informed decision making across all levels for mission readiness at best value.
